Privacy Policy

Apriil Congress AS processes personal information and has adopted this Privacy Policy, which explains how we treat personal information to ensure fair and transparent processing. This Privacy Policy explains how the personal information which you register on the registration site is processed. We are only processing personal information which is relevant and necessary for our cooperation with you, or to fulfil our contractual or legal obligations.

We process data in accordance with the European General Data Protection Regulation (Regulation (EU) 2016/679 of the European Parliament) (the "GDPR") and the applicable acts on processing of personal data in the country where the Congress is taken place.

The registration site is hosted by an external data processor. Pursuant to the GDPR, Aprill Congress AS has entered into a Data Processor Agreement with the external data processors hosting the registration site.

Data Controller

Apriil Congress AS is the data controller of the personal information which you register on the registration site, and the personal information which we collect or receive as part of our services. Below is our contact information:

Registration process on the web site

We only ask you to provide information necessary for the registration process, including any additional services/facilities booked by you in connection with your registration/participation, or to meet our contractual or legal obligations linked to your registration/participation.

The data processing activities for the registration process will generally include the following categories of personal data; name, email address, mobile phone, company name and department, company address, reference no.

As part of the registration process information on your name, contact information, company name and department, your booked services/facilities and the total billing amount will be processed to the Organiser. Further, we may process your information to third-party sources for the fulfilment of the services/facilities booked by you on the registration site or contracted with the Host (i.e. information will be processed to relevant third-party sources such as hotels, venues, restaurants, limo/coach services, guides or other relevant land services). Processing to third-party sources will only take place when it

is relevant and necessary for the fulfilment of the services/facilities booked by you or the Host.

The information registered on the registration site will be processed either by email or through websites to the Host and relevant third-party sources. When processing personal information, we will take appropriate measures to comply with the GDPR and the applicable acts on processing of personal data in the country where the Congress is taken place. The information is not transmitted to countries outside the EU/EEA.

Special categories of personal data

According to the GDPR a consent is required when processing special categories of personal data. Special categories of personal data include inter alia data revealing racial or ethnic origin, political opinions, religious or philosophical beliefs, or trade union membership, data concerning health, data concerning a natural person's sex life or sexual orientation and any personal data relating to a child under the age of 13. We will only process such special categories of personal data based on your consent in writing or facilitated via the registration process (cf. GDPR article 6). Special categories of personal data will only be processed to third-party sources in case it is necessary for the fulfilment of the services/facilities booked by you or the Congress Host (ie. special requirements on food, health and religion may be processed to hotels/venues/restaurants). As part of the registration process, if you register such special categories of personal data on the registration site in the box "special requirements ".

Payment

In case you make an online payment by credit card on the registration site, your payment will be processed through a SSL secured window. All communication is encrypted and goes through Stripe (payment gateway). When the payment has been made, a receipt will be sent to the e-mail address submitted by you. Apriil Congress AS does not store any credit card details on our servers. In case you pay by invoice, the invoice will be sent to the email address submitted by you.

Registering information on the registration site regarding other participants

In case you register personal data on the registration site regarding other participants, you agree that you have notified any other person whose personal data that you provide to us of this privacy policy and, where necessary, obtained their consent so that we can lawfully process their personal data in accordance with this policy. Please see the section" special categories of personal data" for information on when a consent is required.

Processing of personal information as part of our contracted services

In special cases we may receive personal information regarding participants directly from the Host or other clients/partners linked to the meeting. When handling such personal information, we rely on the authority of the Host or our clients/partners to act on behalf of the participants. Further, we base our processing on the fact that the Host or our clients/partners have obtained a lawful basis for the processing of personal information to Apriil Congress AS. Furthermore, we base our processing on the fact that the Host or our clients/partners have provided all relevant information to the participants upon collection of the personal information cf. the GDPR and the applicable acts on processing of personal data in the country where the Congress is taken place.

Legal basis and erasure

Our legal basis for processing the personal information received or registered on the registration site is based on the performance of a contract with you, the Host or clients/partners linked to the meeting, compliance with our legal obligations, our legitimate interests or in special cases your consent, (cf. GDPR article 6).

The personal data registered on the registration site will be deleted within 6 months, unless a legal basis to store it for a longer period is applicable. However, accounting records are kept for 5 years from the end of the financial year to which the material relates (cf. the applicable accounting laws).

Security

All IT-services, internet sites and cloud solutions which we may use have security measures in place to protect from loss, disclosure, unauthorized access, destruction, alteration or other misuse of personal information.

We are currently using SSL, firewalls, and password protection to secure our data. Personal information is treated on a "need to know" basis. When processing personal information, we take appropriate measures to comply with the GDPR and the applicable acts on processing of personal data in the country where the Congress is taken place.

Your rights

The right to insight on personal information (Right of Access)

You are entitled to gain insight on the personal information which we are processing about you.

The right to rectification

You may free of charge request rectification of inaccurate personal data about you. Further, you may request that we cease to process personal information about you (unless we are statutorily required to process the information).

The right to erasure (right to be forgotten)

In special cases, you have the right to obtain erasure of information about yourself before our ordinary general erasure will take place.

The right to restriction of processing

In certain cases, you may have the right to restrict the processing of your personal information. If you are entitled to restriction of processing, we will only be able to process such personal information – with the exception of storage - with your consent or for the purpose of determining, enforcing or defending legal requirements or protecting a person or important social interests.

The right to object

In certain cases, you may object to our otherwise legitimate processing of your personal information.

Right to transmit information (right to data portability)

You may, in certain cases, have the right to receive your personal information in a structured, commonly used and machine-readable format, and to transmit those data to another data controller.

Complaint to the Data Protection Agency
